District 15 provides free bus transportation for students who live more than 1.5 miles from their designated attendance center or within an approved state-designated hazard area. No stops will be made less than one-half (0.5) mile from the school. Parents may choose to pay for bus service on an annual basis for students not eligible for free bus service. **PLEASE NOTE: Due to the bus driver shortage, paid ridership continues to be limited and only offered if space is available on an existing bus route. Applications will be accepted, but payment will not be accepted until a parent receives notification that their child has been assigned to a bus route. Bus availability will be evaluated after October 1.** If you would like paid transportation for your student, please complete a separate application for each student.
