Background

Bid specifications for Carpeting were posted on the district website and published in the Daily Herald on June 29, 2016. Bids were sent to six vendors. Five bids were received. Carpeting is needed in existing classrooms and additional classrooms being constructed at Conyers Learning Academy and Lake Louise.

Asbestos floor tile was discovered under existing carpet in one portion of CLA. The asbestos abatement and carpet replacement will be included in the summer 2017 life/safety projects. Therefore, administration is only recommending a portion of the carpeting bid at this time.

Recommendation

It is recommended that the Board of Education approve the bid award for Carpeting to Central Rug and Flooring, Evanston, IL, for a bid award of \$16,939.72. It will be an expenditure of the 2016-17 Capital Projects Fund.
