*I further swear that:*

*I shall respect taxpayer interests by serving as a faithful protector of the school district’s assets;*

*I shall encourage and respect the free expression of opinion by my fellow board members and others who seek a hearing before the board, while respecting the privacy of students and employees;*

*I shall recognize that a board member has no legal authority as an individual and that decisions can be made only by a majority vote at a public board meeting; and*

*I shall abide by majority decisions of the board, while retaining the right to seek changes in such decision through ethical and constructive channels.”*
