In keeping with CCSD 15's Strategic Plan, the Department of Instruction is continuing to review instructional practices and curricula adoptions. Data analyses and a review of current materials supports the need for new comprehensive literacy curriculum and resources for elementary K-6. After an in-depth exploration of many different programs, materials and resources available, it was determined that Fountas and Pinnell Classroom (FPC) is best suited to meet the needs of our teachers, students and families. FPC strongly aligns with the district's vision of teaching and learning, our current instructional frameworks of reading and writing workshop, and our growing expertise in the use of literacy assessments and data. Stage 1 implementation has begun in this school year.

Fountas and Pinnell Classroom (FPC) is a first-of-its kind system for high-quality, comprehensive core literacy instruction grounded in responsive teaching using a data-driven, inquiry-rich, multi-text approach to teaching reading, writing, phonics and word study. The researched-based, student-centered instructional materials and teacher resources help all teachers to create a dynamic learning environment where all students are fully engaged. It is comprised of seven instructional contexts that fit into whole-group, small-group and independent learning opportunities: Interactive Read-Aloud, Shared Reading, Reading Minilesson, Phonics, Spelling and Word Study, Guided Reading, Book Clubs/Literature Discussions and Independent Reading. Using the instructional contexts of FPC in a cohesive way, coupled with high-impact teaching, enables all students to grow as thoughtful users of literacy together in a community of literacy learners.

We are requesting approval to purchase additional materials for third grade at Virginia Lake School and new kindergarten sections at Frank C. Whiteley, Kimball Hill, and Virginia Lake Schools. The cost for these additional materials is \$60,118.74.
