RE: Action Item – Revised Bid Award #19-033 Further Processed Commodity Foods and Commercial Equivalents

The Further Processed Commodities Bid #19-033 was awarded by the Board in June 2019 based on the recommendation for the bid award to be split between Gordon Food Service, Kohl Wholesale, and Performance Foodservice.

Upon receipt of the results of the bid, Performance Foodservice sent the attached letter declining the award of their portion of the bid – Bongards Cheese Curds and McCain Sweet Potatoes. Therefore, it is recommended these two items be awarded to the next lowest bidders.

Gordon Food Service was the next lowest bidder for Bongards Cheese Curds in the amount of \$1,438.00. Kohl Wholesale was the next lowest bidder for McCain Sweet Potatoes in the amount of \$9,382.25.
